Philadelphia Wage Tax rates will be reduced for taxable compensation paid on or after January 1, 2006. At that time, the Philadelphia resident rate will be **4.301%** and the non-resident rate will be **3.7716%**.

You can pay Real Estate tax on-line by credit card (VISA, MasterCard and Discover cards). A user fee of 1.9% will be added to the amount paid.
